We are able to provide all of the personnel types that were listed in the RFQ. Rates would be anywhere from \$90-\$158/hr with overtime after 40 hours per week; this is based on the rates that we received in FL and NYC for our travelers. They are able to work in 2-week periods with possibility of extensions (given by the state) and are willing to work around COVID-positive patients. They will also work however many hours are needed. Many of our testing sites scheduled travelers 60-84 hours per week. Most of our personnel will be coming from Florida, but we do have others in other parts of the country since we staff on a nationwide basis. If we can be advised on which states to "avoid" for NH state entry purposes, we would be happy to do so.
