



Tip of the Week: COVID Reporting - PCR

HHS and FDA require every SARS-CoV-2 test (negative and positive) performed by a laboratory to be reported to the state health department (of the patient's address) Laboratories will report negative and positive PCR results: https://www.hhs.gov/sites/default/files/covid-19-laboratory-data-reporting-guidance.pdf

COVID-19 is a nationally notifiable disease and a reportable disease in Connecticut. All CT healthcare facilities and providers are mandated to report cases of COVID-19.

Ordering providers are responsible for the reporting of COVID cases

- **Nursing homes** fulfil the requirement by entering detais about positive resident cases on the DPH portal line list.
- Care partners complete case report forms for staff who test positive on a test they ordered.
- LTCFs are responsible for reporting COVID cases when they ordered the test

Tip of the Week: COVID Lab Reporting - Antigen

<u>CMS and FDA require every SARS-CoV-2 antigen test (negative and positive) performed</u> <u>in a facility to be reported to the state health department.</u>

For NHs: The easiest and the preferred method is via NHSN (recent updates!)

- Use NHSN to report all negative and all positive tests done for resident, staff and visitors.
