SUBJECT: Updated booster recommendations, and Long-Term Care Facilities (LTCF)

pharmacy matching support

Following the CDC's recently updated recommendations regarding booster vaccines for LTCF residents, we are reaching out regarding support available to connect you with LCTF pharmacy partners.

As you may have already learned, there are now booster recommendations for all three COVID vaccines for people 65 years and older and residents in long-term care settings. All LTCF residents and staff will be eligible for boosters according to the following guidelines:

- LCTF residents and staff who received Moderna or Pfizer vaccines are eligible 6 months after their second dose.
- LTCF residents and staff who received J&J vaccines are eligible 2 months after their second dose.
- In addition, individuals may receive a booster dose that is a different vaccine type than they originally received for their primary series. Any vaccine product can be administered for a booster dose.
